

# International Alliance for Invitational Education

## *Invitational Education Toolkit End User License Agreement*

The International Alliance for Invitational Education (IAIE) is the sole publisher of the professional development training program entitled, *The Invitational Education Toolkit: The Educator's Guide to Positive Climates for Learning, Leading and Living*® (hereinafter known as *IE Toolkit*). The *IE Toolkit* is the sole property of IAIE who determines all distribution, use regulations, and pricing. The *IE Toolkit* consists of printed and electronic materials that are copyrighted. Some materials are licensed to IAIE solely for use in The *IE Toolkit* (i.e. video, published excerpts). Materials may be updated as deemed necessary by IAIE. Current license holders have access to all updates made to the *IE Toolkit*.

After purchase of an *IE Toolkit* license, the purchaser is required to review this End User License Agreement, then reply by email to [iaie@invitationaleducation.net](mailto:iaie@invitationaleducation.net) agreeing to the terms of the Agreement as stated by typing "I agree" in the body of the email. The purchaser will then receive their Toolkit license access codes.

In the event a purchaser chooses not to accept the terms of this Agreement, he/she will receive a full refund in lieu of the license and access codes upon written request.

IAIE grants you, the purchaser, limited license to use the *IE Toolkit* solely for non-commercial purposes strictly in accordance with the terms of this Agreement. This end user license Agreement is non-transferrable and assigned to a specific building as indicated by the address entered by the purchaser at time of purchase. ***If the "bill to" address is not the building address for use, state building use address in your reply email.***

Individuals and entities (such as schools and school districts) that purchase an *IE Toolkit* license are authorized to use the *IE Toolkit* for professional development at **a single building location**. As the purchaser, you agree not share the *IE Toolkit* access codes or materials with other individuals or entities, or use them in any other building or organization. Purchasers wishing to use the *IE Toolkit* in multiple locations within an organization, may purchase each additional building license at half price.

This Agreement may be terminated without prior notice from IAIE in the event that you fail to comply with any provision of this Agreement. Any License Holder who violates this Agreement will have their *IE Toolkit* access terminated without refund. Further, they will be assessed full cost of single site licenses for each location violation, including reasonable legal and administrative fees required for enforcement.

You agree not to, and will not permit others to license, sell, rent, lease, assign, distribute, transmit, host, outsource, or otherwise commercially exploit the *IE Toolkit*, in whole or in part, or make the *IE Toolkit* available to any third party. IAIE remains owner of all titles, copyrights, and interests of the *IE Toolkit*, and "Invitational Education" is a registered trademark.

In the event that the *IE Toolkit* is inaccessible for reasons attributable to IAIE or its service provider, for any reason whatsoever, the sole remedy to the licensee is for IAIE to extend the expiration date of the license for the same duration as the reported outage.

If any provision of the Agreement is held to be unenforceable or invalid, such provision will be changed and interpreted to accomplish the objectives of such provision to the greatest extent possible under applicable law and the remaining provisions will continue in full force and effect.

There are no changes to this Agreement explicit or implied except as in writing signed by an officer of IAIE.
